MILD TRAUMATIC BRAIN INJURY PROGRAM OF CARE

- Outcomes/RTW 76% of injured/ill persons improved or maintained an LOE status

MENTAL STRESS INJURY PROGRAM

The following information was presented by Ryan Holder (WSIB)

- Presentation available with meeting minutes
- The Mental Stress Injuries Program is a specialized unit dedicated to the adjudication and management of claims involving psychological injuries
- Improvement Initiatives:
 - Goal Attainment Scaling A recovery and navigation tool to support communication and return to work. Fully integrated in August 2021
 - MAP/Psychological Demands Analysis tool a multi-functional tool intended to ensure a good fit between a worker's mental, emotional, and interpersonal competencies and the requirements of their job or alternative work. MAP is a more elaborate cognitive demand analysis. Under development.
 - MSIP Service Delivery Enhancements Opportunity to look at individual case characteristics. Currently in pilot.
