#### **WSIB GENERAL UPDATES**

The following information was presented by Gavin Polkan & Debbie Jeffery (WSIB):

- Current organizational structure is undergoing some internal changes to better align for services being provided. There will be two lines of business operations & account management.
  - Hope to decrease business process that doesn't make sense and to embed more case management principles and return to work earlier in claim process
  - During Phase 1 (Current) Reorganize leadership structure
  - Includes the merger of occupational disease, serious injury program & health services and healthcare programs together into the new specialized claims department
  - Phase 2 (2023) Aligning work into new reporting of new organizational structure
- Escalation process April 1 update on website to ensure clear guidelines and procedures
  - Ensure consistent approach
  - o Improve track date and documentation
  - o Documented process with prompts built into system

#### WSIB LONG-COVID CLAIMS UPDATE

The following information was presented by Sharon Vaz (WSIB):

- According to the World Health Organization (WHO) long-COVID occurs in individuals up to 3 months following the onset of COVID and may last up to two months, with no alternative diagnosis/explanation for symptoms
- Long-COVID has up to 200 different symptoms associated with it, including: fatigue, shortness of breath, chest pain, cognitive disfunction (brain fog), and Post-Exertional Symptom Exacerbation (PESE)
- WSIB refers COVID-19 claimants to special assessment program to clarify diagnosis and recommendations for treatment and RTW
- COVID-19 case management continues to be done by a dedicated team. However, any time a COVID claim gets complicated (i.e. cardiovascular damage, organ failure) case management transitions the claim to the Occupational Disease team
- The usual 4–6-week RTW plan does not typically work for long-Covid cases. Best results seen when start with minimal hours and build up over several months. Pushing too quickly can result in relapse. Rehab is crucial to increasing activities
- Allowance rate was high at beginning of 2022, but has been trending downward since August 2022
- Within Schedule 2, 96% of claims are off benefits within two months
